

## **Request for Proposal** (Retender) Lease and Management of Boston Public Bathing Beach

The National Environment and Planning Agency (NEPA) is seeking to find interested parties, including private sector partners to operate and manage the Boston Beach, part of Boston Estate in Portland, primarily as a public bathing facility. The property is located on 5,311.5 sq. m of land next door to the famous Boston Jerk Centre in Portland, Jamaica.

The Boston Beach is used for various public activities including swimming, surfing and entertainment. In 2016, with support from the Tourism Enhancement Fund (TEF) the beach was rehabilitated and the following activities undertaken:

- Rehabilitation of the existing guard house and new pedestrian entry
- Construction of parking areas (upper and lower levels)
- Upgrade of existing stairs
- Rehabilitation of the outdoor shower stalls
- Renovation of the bathrooms/changing rooms, the existing restaurant and jerk pit
- Construction of Gazebos and Retaining walls

As custodians of a number of public beaches, National Environment and Planning Agency (NEPA)/Natural Resources Conservation Authority (NRCA) are inviting interested parties to submit proposals to include a comprehensive Business Plan for the operation and management of the beach.
