The proposed activity will result in significant and irreversible damage to the seagrass beds and coral reefs that are located within and adjacent to the earmarked dredge sites.  2. The mitigation measures required to compensate for the potential loss and deleterious impacts to these sensitive benthic resources were not adequately addressed in the supporting documentation submitted for review. Further mitigation is unlikely due to the significance of the potential impacts.  3. It is the considered opinion of the Agency that the volume of sand to be removed from the borrow areas would have a significant negative impact on the meiofauna and other organisms that burrow into the sand. The depth of sand to the underlying bedrock was less than 1

metre in some places and the removal of the sand down to hard-bottom/pavement would result in the loss of habitat for these organisms and prevent future recruitment of seagrass beds as there would be no suitable substrate available.

- 4. The removal of that volume of sand within the borrow areas may result in the destabilization of the nearby/surrounding reef structures. This may in turn result in the loss of these structures and the associated habitat and species due to their eventual loss resulting from their collapse.
- 5. The estimates of the volume of sand available within the reserve areas were based on an assumption of a uniform depth to bedrock of a minimum of 1 metre. The investigations of the Agency reveal that the depth to bedrock was not uniform and there were several areas with less than the required 1 metre depth. The required volume of material is therefore unlikely to be available and in light of the proximity to sensitive benthic resources and the shallow depth of the bedrock, without a more precise volumetric assessment of the sand available the impact on the environment is assessed as being too significant.
- The relocation of the seagrass beds that will be impacted is not feasible and hence is not recommended. The dominant species of seagrass found within allocated sites is Syringodium sp. The methods of relocation available have not been demonstrated to be suitable as it is known to be a difficult and expensive species to relocate and the survival rates from such an activity are usually extremely low and not economically feasible.
