An assessment of images from Google Earth for the period 2001 to 2009 and areal photographs taken by the Agency in 1991, suggests that the large beach now present at the location was likely as a result of a single meteorological event (likely a hurricane or tropical Jamaica) which storm offshore generated long period swells. As such, it is clear to assume that if another similar event does not occur, the pit created by the sand mining activities will not be filled in the short course. The occurrence of this meteorological event is the sole parameter used in the model to predict the time for the infilling of the excavation pit and based on the above, this prediction is likely to be overly optimistic. It is possible that another similar event may not occur for another 15 years, as was the case between 1991 and 2007. The sand mining at this location could lead to the complete destruction and loss of this natural beach, as the natural, day to day processes occurring at this beach would not allow for the infilling of the excavation pit.

The proposed activity will negatively impact documented sea turtle nesting activities along this section of coastline as the pit, if not filled, will prevent

	adult sea turtles from accessing the lightly grassed areas behind the beach. Further, if the adult sea turtles are able to navigate the terrain created by the excavation, the hatchlings will not be able to find their way to the water and will become trapped in the excavation pit.
