Environmental management – The control and guidance of human interactions and impacts on the environment, as well as the development of strategies to manage and conserve natural resources.

Global warming – A phenomenon believed to occur due to buildup of carbon dioxide and other greenhouse gases caused by human activities.

Ground water-All water found beneath the surface of the ground which is not chemically combined with any minerals present.

Habitat- The natural physical environment in which an organism or ecological community normally lives or occurs.

Mangrove- Evergreen trees and shrubs that grow in dense thickets or forests along tidal estuaries, in salt marshes, and on muddy coast in the tropics and subtropics.

Pollution- The introduction of pollutants into the environment usually through the contamination of soil, water or atmosphere.

Surface water- All water naturally open to the atmosphere, including rivers, streams and estuaries.

Water quality – The physical, biological and chemical organoleptic (taste related) properties of water.

Watershed- An area of land that catches precipitation and drains or seeps onto a marsh, river, stream or groundwater.

Glossary

Atmosphere – The layer of gases surrounding the earth and retained by the earth's gravity.

Biodiversity – The variability among living organism from all sources: terrestrial, marine and other aquatic ecosystems, as well as the ecological complexes of which they are part.

**Climate – The long-term average weather of the region, including typical weather patterns, the frequency and intensity of the storms, cold spells and heat waves.

**Climate change - A change of climate which is attributed directly or indirectly to human activity that alters the composition of the global atmosphere and is addition to natural climate variability observed over comparable time periods.

Coral reef- A large, ridge-like underwater formation created from the exoskeleton of coral polyps.

Coastal zone - Lands and waters adjacent to the coast that exert an influence on the uses and ecology are affected by the sea.

Development - The application of human, financial, and physical resources to satisfy human needs.

Ecosystem – Dynamic complex of plant, animal and micro-organism communities and their non-living environment interacting as a functional unit.

Endangered species – A specie that is facing a very high risk of extinction in the wild in the near future.

Endemic Species- A specie limited to a specific region or locality.

Environmental degradation- The deterioration of the environment's quality from ambient concentrations of pollutants and other activities and processes like improper land use, species extinction

The Access to Information (ATI) Act was passed in June, 2002. It gives members of the public the legal right to access official government documents which would otherwise be inaccessible from the Documentation centre. Students, therefore, may also utilize this medium to access certain documents. It should be noted that if access is granted, documents will be made available to applicants within **thirty (30)** days. However it may take up to sixty (60) days.
